### Contents

### From the Commissioner for Children

This has been another challenging and rewarding year for the Commissioner for Children's office. I would like to sincerely thank my staff for their hard work and dedication throughout 2005-06. This has enabled a small office to manage a diversity of outputs including monitoring complex and sensitive matters, preparation of reports and submissions and promoting the best interests of children and young people in matters relating to their health, welfare, care, protection and development.

I am pleased to report that there have been a number of projects of significance undertaken this financial year, primarily regarding Child Protection Services and Youth Justice.

The troubling state of Tasmania's child protection system has received much public attention and 2005-06 saw the commencement of the *Child Protection Service Development and Operational Improvement Project*. This project involves a review of Tasmania's child protection system, which will continue to be conducted in partnership with the Deputy Secretary of the Department of Health and Human Services throughout 2006.

Following allegations of abuse raised by residents at Ashley Youth Detention Centre, in late 2005 I chaired a review of the relevant systems and protocols in place to ensure resident safety at the facility. The review was undertaken in collaboration with the Department of Health and Human Services, namely the then Director of Children and Families and the Executive Director of Corporate Services. In early 2006, I also completed an investigation into the high number of young people on remand in Tasmania pursuant to a request from the Minister for Health and Human Services under section 79(e) of the Children, Young Persons and Their Families Act 1997 in the 2004-05 financial year. The State Government has made positive progress toward implementing the majority of the 23 recommendations contained in the final report Review for the Secretary DHHS of Resident Safety - Ashley Youth Detention Centre. The Government also voiced their strong commitment to adopting the recommendations resulting from my investigation into youth remandees and it was decided that a whole of Government working group was required to address the issues raised in the report. However this working group has not yet been established.

A substantial amount of work was also completed during 2005-06 pursuant to a number of reports that will be completed in the coming year. These include a report arising from the Government's adoption of recommendations 8 and 9 of the Ombudsman's Report '*Listen to the Children*, Review of Claims of Abuse in State

Care as Children'. Two additional staff members have been employed for six months to complete this report.

The next financial year will also see the completion of a report to the Minister for Health and Human Services on Child Death Review processes throughout Australia and their possible application in Tasmania.

As evidenced above, my collaborations with government and the non government sector continued to bring about successful outcomes in 2005-06. I have been involved with a variety of committees, working groups and panels that have endeavoured to produce significant, long lasting change for children, particularly those most at risk. However, there remain areas where the State Government's express commitment to issues regarding children and young people has not been supported by the action required to translate this commitment into practice.

In 2004-05 | produced a consultation paper Screening of Individuals Who Work With Children in Tasmania. In my Annual Report for that year I noted that this issue was a major outstanding matter to be progressed during 2005-06. Screening or 'background checking' is the process by which employers examine the criminal history, employment history and other relevant background information of a person to assess whether they pose a risk to the children they will be working with. Screening is a fundamental feature of a child-safe environment however there is no legislative requirement for employers to screen all people who work with children in Tasmania. In 2004-05, New South Wales and Queensland had existing systems for screening or 'background checking' people who work with children. Since that time, Western Australia and Victoria have also established systems for screening workers and are now operating working with children checks. All remaining states are in the process of developing legislation on this issue. However, despite my continued discussions with the past and present Minister for Health and Human Services and my expectation that the Government would be in a position to announce their direction regarding the proposals contained in my consultation paper by the end of 2005, no further progress has been made. At this stage, there is no agreed action to progress screening in Tasmania nor is there any indication that legislation will be drafted in the coming year.

Whilst it was a positive development for the State Government to establish the Office of Children and Youth Affairs, as well as the completion of the necessary project work and passing of legislation for the establishment of the Early Years Foundation, it is very disappointing to observe that these initiatives have not amounted to any discernable outcomes for children. Furthermore, the \$750,000 recurrent funding committed to the Early Years Foundation by the previous Minister for Education commencing in the financial year 2005-06 has been 'lost' through inaction in not establishing the Early Years Foundation. The Office of Children and Youth Affairs

appears little more than a change of administrative arrangements and a renaming of the former Office of Youth Affairs.

At the service delivery end of the spectrum, vulnerable children in State care continue to be jettisoned from Family Group Homes during the holiday periods of their carers. These and many other practices (for example, transporting children unaccompanied in taxis) are not consistent with the State being a conscientious and responsible parent.

Notwithstanding the continued ongoing assistance provided by the Department of Health and Human Services in relation to the operation of this office, it would be far more desirable for the office, together with other statutory offices in Tasmania to be brought together. Each could function autonomously but would share resources as there would be sufficient economies of scale. In doing this, both the independence and perception of independence would be enforced.

Finally, the modern trend of having large Government departments providing a range of programs in the hope of developing synergies led to the establishment of the Department of Health and Human Services some years ago. However the focus and priority of this large department is dominated by health issues to which other programs are necessarily subservant. It is timely, in my view, for the administrative arrangements for the provision of services to children and families to be revisited and examined as it seems highly likely that health issues will continue to dominate the Department of Health and Human Services' agenda. This observation does not detract from the high level of co-operation and professionalism I have experienced in dealing with the Department of Health and Human Services.

I would also like to take this opportunity to thank the children and young people who are members of my Children and Young Persons Consultative Council, whose opinions and perspectives have been a vital contribution to my work. I would also like to thank my Children and Young Persons Advisory Council who share their expertise with this office so generously and inspire us all to continue to make a difference to the lives of children and young people in Tasmania.

### A Snapshot of Children and Young People in Tasmania

#### Population and Health

- As of 1 December 2005, the total population of Tasmania was 487,185.<sup>1</sup>
- At 30 June 2005, there were an estimated 117,094 children aged 0-17 (inclusive) in Tasmania (approximately 24% of the population)<sup>2</sup>.
- In 2004, Aboriginal and Torres Strait Islanders represented a small proportion (8%) of young Tasmanians aged 10-17 years<sup>3</sup>.
- In 2004-05, there were 1.99 births per woman in Tasmania (compared with 1.88 in 2000-2001) and 1.8 births per woman nationally in 2005. There were 6,288 births in Tasmania in 2005 compared with 5,801 in 2000<sup>4</sup>.
- In 2005, 93.4% of Tasmanian children aged 12-15 months were fully immunised compared to 91% nationally. In the 72-75 month age group, 86.6% were fully immunised, compared to 84% nationally<sup>5</sup>.

#### Education

- The proportion of Tasmanian children using Australian or Tasmanian government funded and/or provided child care in 2004-05 was 34.3% for 0-5 year olds and 15% for 6-12 year olds<sup>6</sup>.
- In 2005, there were 83,000 school students in Tasmania. 73,500 students were in government schools (or 89% of all full time students).<sup>7</sup>

- In 2005, the Year 7/8 to Year 12 apparent retention rate for males was 58.4%. This is the second lowest retention rate for males in Australia (after the Northern Territory) and is significantly less than the national rate of 69.9%. The retention rate for females was much higher, at 76.5% although this is still below the national average of 81.0%.<sup>8</sup>
- In 2004 the number of people participating in higher education in Tasmania (18,100) was the second lowest in the nation (after the Northern Territory).<sup>9</sup>

#### **Care and Protection**

- 12,745 notifications had been received from July 2005 to June 2006, of which:
  - 3,705 notifications were referred for further investigation (2,456 were allocated and 1,249 were unallocated);
  - 963 investigations were finalised for that year;
  - 517 were found to be substantiated cases of abuse or neglect<sup>10</sup>.
- At 30 June 2005, 716 children were on care and protection orders in Tasmania. This represents a rate of 6.1 per 1000 children (aged 0-17 years), compared to the national rate of 5.2<sup>11</sup>. This rate has been increasing in Tasmania since 2001.
- At 30 June 2005, 4.9 per 1000 children were in out-of-home care (equal to the national rate)<sup>12</sup>.

#### Juvenile Justice 13

- There were a total of 113 juveniles aged between 11 and 18 years who were on remand at Ashley Detention Centre at least once between 1 July 2004 and 30 June 2005.
- Three quarters of these remandees were aged between 15 and 17 (the median age was 16).
- Nineteen per cent of these juveniles identified as being Aboriginal.

- Just under half (45%) of the juveniles were placed on remand more than once over the one year period.
- 39 per cent of juveniles placed on custodial remand, whose matters had been finalised, did not receive a detention sentence as a sentencing outcome during the one year period.

### **Our Vision**

A community where the interests of children are the paramount consideration in any decisions affecting their health, welfare, protection, development and education.

### **Our Objectives**

Firstly to promote the health, well being and development of children. Secondly to promote Government's responsiveness to the needs of children, especially those most vulnerable. Thirdly, to promote children's involvement as active and contributing decision makers in their lives and their communities. Fourthly, to support families and communities in the care and protection of children.

### **Our Strategy**

The Commissioner for Children is an independent office responsible to the Parliament of Tasmania. In essence, the Commissioner's functions include promoting the rights and well being of children along with examining the policies, practices and services provided for children and any laws affecting the health, welfare, care, protection and development of children. These functions are very broad and there is consequently a need to focus on matters that will make a real difference to the lives of children in Tasmania especially those more vulnerable children and young people.

# What Does the Commissioner for Children Do?

The Commissioner examines legislation, policy and practices used by Government Departments that affect the health, welfare, care, protection and development of children to ensure they operate in the best interests of the child. "Children" includes all children under 18 years of age. The Commissioner provides advice on the development of these practices and policies and makes recommendations for their improvement.

The Minister for Health and Human Services can ask the Commissioner to investigate and give advice on specific issues.

The Commissioner also works to increase public awareness about important issues affecting all children and youth in Tasmania.

To do all these things, the Commissioner:

- Identifies and acts on issues affecting children and young people,
- Researches issues related to children;
- Seeks the views of children and young people about issues affecting them; which includes having a Children and Young Persons Consultative Council;
- Consults with Ministers, Government agencies, non-Government organisations and the public; and
- Is informed by the Adults Advisory Council who advise him in his work.

In all his work the Commissioner must act independently, impartially and in the public interest. The Commissioner for Children is appointed by the Governor and is responsible to Parliament. An Annual Report is provided to Parliament on the work of the Commissioner.

## Enquiries from Government Agencies, Non-Government Organisations and the Public

In 2005-06, the Commissioner for Children's office received approximately 202 enquiries from individuals, organisations and Government agencies. These included enquiries received by phone, email and letter.

The nature of enquiries ranged from requests for general information on issues related to children and youth, to formal complaints about a service or agency.

The Commissioner for Children does not have the power to investigate individual complaints, other than when requested to do so by the Minister for Health and Human Services. Individuals who contact the office were advised to contact relevant Government agencies or non-Government organisations to assist them further. Callers were commonly referred to the following services:

- Tasmanian Ombudsman
- Legal Aid Commission of Tasmania
- Hobart Community Legal Service
- Department of Health and Human Services
- Department of Education

### Requests from the Minister for Health and Human Services

Recommendations 8 and 9 contained in the Tasmanian Ombudsman's report '*Listen to the Children*, Review of Abuse from Adults in State Care as Children'

In late 2004 the Tasmanian Government announced that the Ombudsman would conduct an independent review of claims of past abuse in State care. The report *Listen to the Children* was released in November 2004 and made eleven recommendations to Government.

Recommendations 8 and 9 related to further work to be undertaken by the Commissioner for Children. In response to Recommendation 8, the Minister for Health and Human Services at the time, the Honourable David Llewellyn, requested that the Commissioner for Children conduct an investigation into twelve recent cases of alleged abuse and the Departmental response to those allegations. Recommendation 9 dealt with specific matters requiring the advice of the Commissioner regarding the provision of services to children in out of home care and the protocol between the Department of Health and Human Services and the Department of Education. Additional resources, in the form of two positions (one a senior project officer and the other a project officer) were provided to the office to undertake this significant work in early 2005.

This major report will be presented to the Minister for Health and Human Services in the near future, providing a strong foundation to work currently being undertaken to reform the provision of child protection services in Tasmania.

#### Investigation into the high number of young people on remand

In the 2004-05 financial year, the then Minister for Health and Human Services, the Honourable David Llewellyn, requested an investigation into the high number of young people on remand at Ashley including an analysis of the reasons and contributing factors and the recommendation of possible strategies to address the issue. Following the collection of relevant data and meeting with stakeholders as reported in my last Annual Report, the Australian Institute of Criminology undertook an analysis of the data and the final report, Review of Juvenile Remandees in Tasmania was released in April 2006. The issues examined in the report included the high proportion of Ashley residents on remand; the length of time spent on remand; the relevant legal framework; sentence outcomes; data collection; and health, welfare and protection issues. Recommendations included a review of previous initiatives in this area, the development of inter-agency protocols between Youth Justice Services and Child and Family Services for monitoring and assisting youth on remand, improved data collection, the development of bail legislation specific to children and the development of bail options. Whilst it was pleasing to see the acceptance by the Government of the recommendations contained in this report unfortunately there has not been any discernable action taken in relation to the recommendations.

#### Child death review processes

In June this year, the Minister for Health and Human Services, the Honourable Lara Giddings, requested advice regarding the need for a child death review process in Tasmania as well as options for establishing such a process. A report and recommendations will be provided to the Minister early in the second half of 2006 and is expected to be made public.

The child death review process provides a mechanism for monitoring and reviewing the effectiveness of the child protection system. Its principal aim is to identify whether changes to policy and practice could improve the child protection system's response to children at risk so that future child deaths, in similar circumstances, may be avoided.

The report will discuss the reasons for the development of child death review processes in other Australian jurisdictions and will examine child death review models in those jurisdictions. The report will examine the need for a child death review process in Tasmania and present options for establishing this process.

# Initiatives Undertaken by the Commissioner for Children to Promote the Safety, Care and Protection of Children

#### Child Protection Service Development and Operational Improvement Project

In early 2006 the above review commenced to examine the adequacy and timeliness of the provision of child protection services in Tasmania. This ongoing review is being undertaken at the request of the then Minister for Health and Human Services, the Honourable David Llewellyn. It is being conducted in partnership with Ms Alison Jacob, Deputy Secretary Department of Health and Human Services. The purpose of the review is to examine the child protection system in its wider context, taking into account recent reports that had been released relating to the child protection system (for example, the KPMG report on Family Support Services and the Services and Staffing report). Importantly the process of the review includes wide consultation both within Tasmania and interstate. The review will provide a crucial framework for the future development of a child protection system that is failing the most vulnerable children in Tasmania.

#### Review of Resident Safety at Ashley Youth Detention Centre

Following widely publicised allegations of abuse occurring at Ashley Youth Detention Centre, the Secretary for the Department of Health and Human Services requested that a review be undertaken into the systems and protocols in place to ensure the ongoing safety and well being of residents. This request was in response to an earlier request from the Minister for Health and Human Services to examine certain matters relating to the safety and wellbeing of clients at Ashley. I was asked if I was willing to participate in the review and I agreed to do so with certain caveats that were intended to preserve my independence. The review team consisted of myself, and representatives from the Department of Health and Human Services, the then Director of Children and Families and the then Executive Director of Corporate Services. The review involved a high degree of consultation with and input from residents and staff at Ashley.

The resulting report, *Review for the Secretary DHHS of Resident Safety – Ashley Youth Detention Centre* contained 23 recommendations, including the further exploration of unit allocation / resident segregation; statutory mechanisms for the transfer of serious offenders to the prison system; the establishment of a Youth Parole Board; a review of Standard Operating Procedures; increased educational opportunities for residents; the trial of CCTV; a review of the complaints processes; a resident advocate and Ashley Advisory Group. A number of recommendations have been addressed and the Department of Health and Human Services has remained committed to their implementation.

## Information Session and Forum – Innovations in Advocacy and Support for Children

On 20 April 2006, an information session was hosted to explore initiatives developed in Australia and overseas to advocate for and support children during child protection court proceedings and children who are placed in out-of-home care. The session included presentations on the United States National Court Appointed Special Advocate (CASA) Association and the Queensland Commissioner for Children and Young People's Community Visitors Program. The session was supported by the Australian Foster Carers Association and the CREATE Foundation and was attended by a diverse range of government and non-Government representatives from organisations that provide services to children and their families.

#### Screening of Individuals Who Work With Children in Tasmania

In the previous financial year, I released a consultation paper titled *Screening of Individuals Who Work With Children in Tasmania.* "Screening" refers to the process of inspecting a person's criminal history, employment history and other relevant background information to determine their suitability to work with children. The consultation paper proposed a legislative based system for uniform screening for all employees, volunteers and self-employed people who work with children across Government and non-Government sectors. Currently, there is no legislative requirement to screen all people who work with children other than in the child care industry. Every jurisdiction in Australia has legislation requiring workers to be screened or are in the process of developing such legislation. The consultation paper received overwhelming support. During 2005-06, I continued discussions with Government on how the proposals may be progressed. Regrettably there has been no progress made regarding the adoption of the proposals set out in the consultation paper.

#### **Child Home Injury Prevention**

Child Home Injury Prevention (CHIP) continued to meet throughout 2005-06. I am the current Chairperson and there has been an active and committed executive. A successful Forum was held in Hobart on the 5 May 2006 to promote CHIP to members of the community and the non-Government sector. CHIP also currently provides monetary grants to projects that promote child home safety. There will however be no further grants in the year 2006/07.

#### Paediatric Mortality and Morbidity Sub-Committee Meetings

In 2005-06 I attended meetings of the Paediatric Mortality and Morbidity Sub-Committee Meetings and the Council of Obstetric and Paediatric Mortality and Morbidity. Recently the Council has been conducting a review into a child death and the report findings will be presented to the Government shortly.

### Children and Young Persons Consultative Council

Being on the Commissioner for Children's council is a great way to contribute to the opinions of the day concerning children. I feel that it is important for young people to have their say in the issues that concern us and I am proud to be a part of the Commissioner for Children's Consultative Council. It is also a great way to meet like-minded people. (Priya, Council Member)

The Council is a group of people aged generally between 12 and 17 years established under the *Children, Young Persons and Their Families Act 1997* who share their views on issues affecting children in Tasmania to assist the Commissioner for Children in his or her work.

My work has received vital contributions from the Children and Young Persons Consultative Council throughout 2005-06.Council members have continued to provide their time voluntarily to give thorough and insightful consideration to issues affecting all children and young people in Tasmania. I presented the Council's views on the application of policies and practices that seek to prevent and respond to bullying in Tasmanian schools at the 10<sup>th</sup> Australasian Conference on Child Abuse and Neglect. The Council's views on domestic violence in video games are also being used to inform a joint submission to the Commonwealth Attorney-General to address the issue from the Queensland Commissioner for Children and Young People, the NSW Commissioner for Children and Young People and the Tasmanian Commissioner for Children. I would like to sincerely thank the Council for their willingness to share their ideas and perspectives which have greatly informed my work. The Council met on four occasions in 2005-06 to discuss the following issues:

#### Saturday 23 July 2005 (Launceston)

 Bullying in schools, including the reasons behind bullying, the different types of bullying, discussion of strategies currently used by schools and ideas for new solutions

#### Thursday 8 September 2005 (Launceston)

- Meeting attended by the Deputy Secretary of the Department of Education and the Coordinator of Leaderships and Learning (Department of Education)
